- a) Website membership sign-ups, forum moderator (Environmental Express has volunteered), other concerns?
  - Lyle moderator in his opinion a 20 hour a week job, will need constant attention, spoke with his wife about monitoring during development phase, website takes a lot more time than any other position held in FSEA
  - ii) Suzanne Dave wanted to get TAG going and use forum for that, is there interest?

- iii) Cathie If Lyle is estimating 20 hours a week are we really expecting that much traffic?
- iv) Suzanne members only database required, Tightwire didn't want to set up programming for forum is not going to be used in other areas, members only not live at this time.
- v) Lyle 1<sup>st</sup> question do we want a forum? 2<sup>nd</sup> do we want a members only forum? 3<sup>rd</sup> who do we want to moderate?
- vi) John member only would be less traffic, Suzanne –more difficult to set-up

- xi) Cathie should we have a membership database? Will it allow members to update their info? Suzanne we need to decide what we want, mapping for website should be done before we go further. Carol scope of work and expectations need to be done. Suzanne amount of detail is extremely extensive, being done in pieces is difficult, need scope and how things are connected. Lyle tightwire is making this a bigger deal than needs to be username/password, storing credit card info is not new. We need a database. Suzanne agrees.
